EXTENSION OF PROVISIONAL REGISTRATION OF OXBRIDGE ACADEMY (PTY) LTD AS A PRIVATE COLLEGE

In the letter dated 06 July 2009 *Oxbridge Academy (Pty) Ltd* was informed that it was provisionally registered until 31 December 2015 and that in order for its provisional registration to be converted to full registration it must continue to comply with the requirements for registration and submit valid documentary evidence as proof of such compliance together with annual reports.

Accordingly, I have assessed the documentary evidence together with annual reports submitted for the period under review (2009 to 2015) and have established that *Oxbridge Academy (Pty) Ltd* has satisfactorily complied with the requirements. However, the accreditation report of *Oxbridge Academy (Pty) Ltd* expires on 31 July 2016 and is provisional.


Consequently, *Oxbridge Academy (Pty) Ltd* cannot be converted to full registration. I hereby in terms of Section 31(5) of the *Continuing Education and Training Act No. 16 of 2006* read with Regulation 15(4)(d) of the *Regulations for the Registration of Private Further Education and Training Colleges, 2007*, extend the provisional registration of *Oxbridge Academy (Pty) Ltd* in order to enable *Oxbridge Academy (Pty) Ltd* to fully meet all the requirements for conversion to full registration.

The extended provisional registration of *Oxbridge Academy (Pty) Ltd* takes effect from 01 January 2016 until 31 December 2018. The extended provisional registration of *Oxbridge Academy (Pty) Ltd* is subject to annual review and it may be cancelled should *Oxbridge Academy (Pty) Ltd* fail to maintain its compliance with all the requirements for registration.

Please note that, except for above change in conditions for registration of *Oxbridge Academy (Pty) Ltd* all other conditions applicable to your provisional registration remain the same and in effect as indicated in the letter cited above.
