## **CONVERSION OF PROVISIONAL REGISTRATION OF OXBRIDGE ACADEMY (PTY) LTD (PTY) LTD**

In the letter dated 02 December 2015 *Oxbridge Academy (Pty) Ltd* was advised that its provisional registration has been extended until 31 December 2018, and that, in order for its provisional registration to be converted to full registration, it must continue to comply with the requirements for registration and submit annual reports together with valid documentary evidence as proof of such compliance.

Accordingly, I have assessed the documentary evidence along with annual reports submitted to me and have established that *Oxbridge Academy (Pty) Ltd* was compliant with the requirements for maintenance of its provisional registration in terms of Section 30 of the Continuing Education and Training Act, No.16 of 2006 (CET Act) of the Act.

It is a pleasure for me to inform you that the provisional registration of *Oxbridge Academy (Pty) Ltd* as a private college is converted to full registration in terms of Section 31(6)(a) CET Act.

### **Continuation of maintenance of registration**

In order to continue to maintain its registration, *Oxbridge Academy (Pty) Ltd* must consistently submit documentary proof of compliance with the requirements for registration by submitting annual report on or before **30 April** of each year. Furthermore, to ensure that *Oxbridge Academy (Pty) Ltd* continues to meet the requirements for registration in terms of Regulation 18(a) of the Regulations for the Registration of Private Further Education and Training Colleges, 2007 (Regulations), it must secure re-accreditation before its accreditation expires.

Should *Oxbridge Academy (Pty) Ltd* fail to comply with maintenance of registration requirements as stipulated in Regulation 18 of the Regulations, Section 39 of the CET Act and Regulation 14 of the Regulations will apply, subject to Section 40 of the Act wherein the registration of *Oxbridge Academy (Pty) Ltd* may be cancelled.


While the unique registration number of *Oxbridge Academy (Pty) Ltd* remains **2009/FE07/070** the certificate number has changed to **227**.

Your college's amended certificate of registration and the original copy of this letter will be sent to you by registered mail. On receipt of the new certificate, *Oxbridge Academy (Pty) Ltd* is required to return the certificate of its provisional registration currently in its possession to the Department within 14 days of receipt of the amended registration certificate.

Please note that, except for above change in conditions for registration of *Oxbridge Academy (Pty) Ltd*, all other conditions that were applicable to your provisional registration remain in effect.
